Armetta's Grand Jeté is thrilled to begin an exciting Winter Wonderland Season!

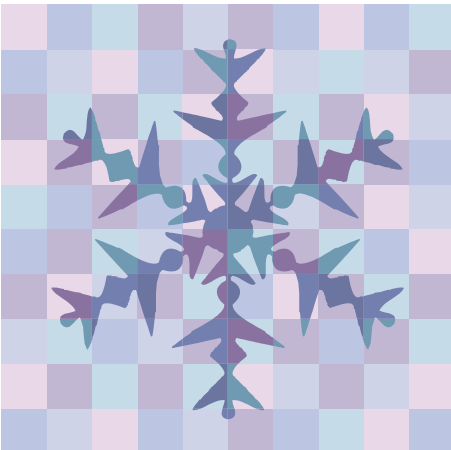
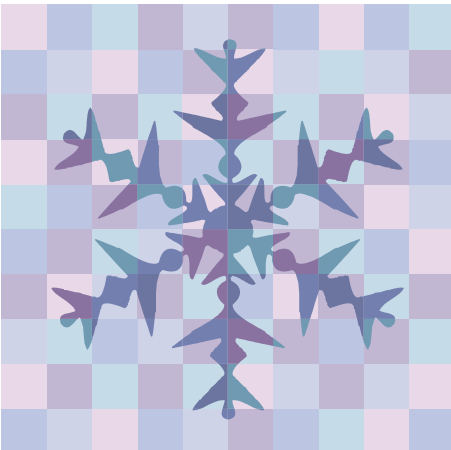
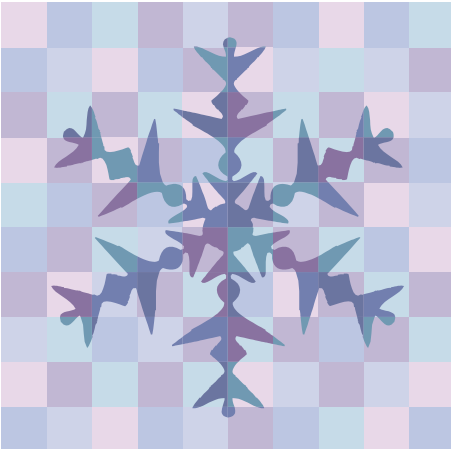

Auditions for placement in the Winter Wonderland will be held on **Saturday, June 9, 2012** at Armetta's Grand Jeté Studio of Dance . Please read carefully the *Rules and Regulations* listed on the back before committing to audition for placement. Audition application is due no later than **June 8 2012**.

# Winter Wonderland Spectacular Guidelines

1. Must be between the ages of 5+ as of 6/8/12. Dancers should come to the audition time based on their ages as of audition day.
2. There is a "Winter Wonderland Participant" non-refundable/non transferable fee of \$153 per dancer. This will help cover costume rental, choreographer fees, and administrative costs. This fee is will can be divided up to \$51/month on 7/1, 8/1, 9/15.
3. There will be 12 scheduled studio rehearsals-all held at the studio, which will be held on Saturdays starting **September 8<sup>th</sup>**. It is mandatory that all dancers attend each scheduled rehearsal. **The studio must be called ahead of time of any known absence.** Dancer's with non-excused or multiple (2 or more) absences **will be released** from the cast and replaced with a back-up dancer (no WW fees will be refunded). Dancers are also required to be at all mandatory dress/technical rehearsals at the Scottish Rites Cathedral (dates listed on next page). Should an emergency situation arise the dancer is to contact the studio as soon as possible.
4. Dancers are expected to arrive to rehearsals **on time** and will need to have made arrangements for timely pick-up.
5. Be ready in proper dancer attire prior to scheduled rehearsal time. Proper dance attire is to be worn during rehearsals. Please follow studio dress code.
6. Dancers are to be on their best behavior during rehearsals and performance. No food/open drink containers/gum/yelling/running/tumbling allowed in studios and at the theater. Please regard teachers and fellow dancers respectfully.
7. Costumes should be handled with care. They do not belong to the dancers and are reused year to year. They must be returned in good condition. Costumes will stay in the possession of the studio and/or costume rental company and will be given out and returned at every dress rehearsal and performance.
8. Costumes that are damaged or lost will result in an \$50 costume replacement fee.
9. Treat the theater and dressing rooms respectfully. Absolutely no touching or playing on scenery, or props!
10. Parents of performers will be responsible for any damage done to costumes, props, scenery, etc.
11. Performers will be asked to participate in Advertising sales for the show program. Details will be provided at a later date.
12. Souvenir 2012 "Winter Wonderland Spectacular" T-shirts will be offered to all cast members.
13. The Video Theatre Crew will be professionally digitally recording in high definition both night performances for DVD purchases. There is no video recording during any performance.
14. Winter Wonderland pictures will be taken on **Sunday, Dec 2<sup>nd</sup>**. Group and individual shots will be available to order and purchase as a keepsake of this performance. Pictures will also be displayed in the Winter Wonderland show program.
15. **October 27<sup>th</sup>**, tickets will go on sale. Tickets will be sold online. Tickets are not sold through or at the studio. All tickets are reserved seating and \$ 9.75 per seat.
16. **Sunday, 12/16** We will host a cast party from 2-3:30 PM.
17. Volunteers will be needed to help with planning cast party, room moms, flower sales & kiss the cast table. In return for your time and help volunteers will receive \$15 off their participant fee.
18. Parents signature is required on audition application to show that you understand all rules and regulations set for each dancer participating in WW. By signing this agreement, the dancer lets us know that he/she is **committed** to the performance and will attend all scheduled rehearsals in preparation for performance. Failure to do so will result in dismissal from cast.
